



# Bloomberg pv modules Puerto Rico

Central to Puerto Rico's future success with residential solar is the net metering law, Act 10-2024, that extended the territory's net metering policy for solar through 2031. Signed into law in January, Act 10 was passed unanimously by the Puerto Rico House and Senate and was unopposed by the island's regulator.

Ilumina, the biggest PV plant in operation in Puerto Rico, has been officially inaugurated by the governor, Luis Guillermo Fortuño Burset, on Oct. 5. The 138-acre solar farm, which uses GPtech PV inverters and a Power Plant Controller (PPC) also from GPtech, will use some 100,000 photovoltaic panels to produce enough electricity to power 6,000 homes.

San Fermin Solar Farm is a 26.54MW solar PV power project. It is located in Loiza, Puerto Rico. According to GlobalData, who tracks and profiles over 170,000 power plants worldwide, the project is currently active. It has been developed in a single phase. Post completion of construction, the project got commissioned in September 2013.

In 2020, the Puerto Rico Energy Bureau mandated utility PREPA to contract 3.75 GW of utility-scale solar and 1.5 GW of four-hour battery storage via six procurement rounds by mid 2023. Three exercises have been staged but US government data indicate Puerto Rico is planning only 126 MW of large-scale solar, on top of the existing 154 MW.
